Held in Tegucigalpa city, Honduras on August 23, 2018. REDCA+ participated in the V Conference of Key Population on HIV and Human Rights, organized by the Foundation LLAVES and the HIV and Human Rights Platform.



The objectives of this meeting were:

General Objective: Promote a space for the Government, Civil society and Cooperation to analyze the current situation in HIV and Human Rights of people with HIV and key population, in order to find solutions that ensure an effective and timely response based on human rights.

Strategic Objective: Identify the progress and challenges of recent years regarding to the HIV epidemic and the human rights situation of people with HIV and key population, where the

findings are identified and recommendations made to the Government, Civil society and Cooperativon for the due post- conference follow up.

Otoniel Ramírez, in his capacity of Regional Secretary of REDCA+, participated as a speaker with the theme: "Importance of political advocacy respect of legal gaps in the field of the promotion, protection, respect and guarantee of the human rights of people with HIV". Case from Honduras.

COORDIATION WORK WITH THE EXECUTIVE SECRETARIAT OF COUNCIL OF MINISTERS OF HEALTH OF CENTRAL AMERICA AND THE DOMINICAN REPUBLIC

During July and August, the Technical Secretariat of RCM worked jointly with personnel of SECOMISCA, giving a follow up to the following topics:

Monitoring the RCM Operating Plan, progress of the Sustainability Strategy of the Regional Response to HIV, reporting of the Regional HIV indicators, follow up to RCM and COMISCA Agreements, follow up to the IREM, among others.

Likewise, the Technical Secretariat participated in training activities related to Monitoring and evaluation, Regional Gender Policy of SICA and International Health Regulations.
